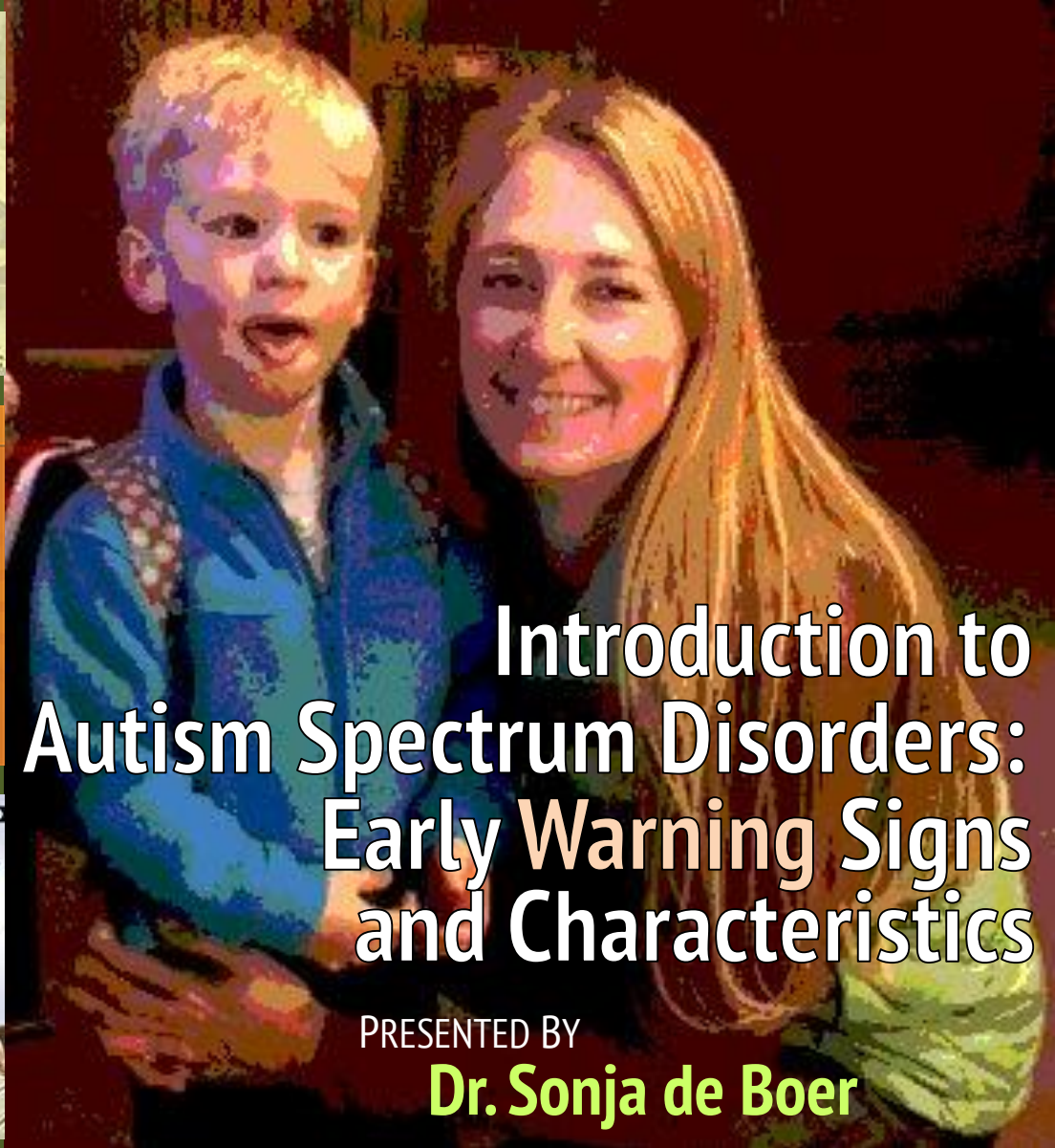
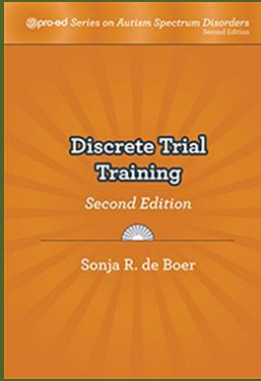
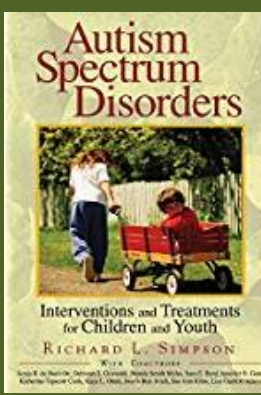

Introduction to Autism Spectrum Disorders: Early Warning Signs and Characteristics

This special training will provide service providers working with very young children (ages 0-5 years) with information about autism spectrum disorders (ASD) such that they will have the knowledge they need to be able to recognize warning signs of ASD and refer a child and family to Far Northern Regional Center to initiate further assessment and early intervention services, and to explain to others about the ASD diagnostic process.

- ✓ Be able to provide a brief and introductory explanation on the characteristics of ASD and how they manifest themselves in young children
- ✓ Recognize early warning signs of ASD and help families (and professionals working with the child) to seek further information and resources regarding ASD and services
- ✓ Be able to explain the ASD Screening and Diagnostic process to other professionals and families
- ✓ Accurately and appropriately refer and assist families in seeking diagnostic and intervention services for children with ASD

INTRODUCTION TO AUTISM SPECTRUM DISORDERS: EARLY WARNING SIGNS AND CHARACTERISTICS



Sonja de Boer is a Board Certified Behavior Analyst and obtained her Ph.D. in special education and psychology and research in education, with an emphasis on early intervention for children with Autism Spectrum Disorders (ASD). She has 25 years of experience working in early childhood special education, early intervention services, Applied Behavior Analysis (ABA), with students with disabilities, and specifically children with ASD. She has designed 0-3 in-home services programs, 3-5 preschool programs (both intensive ABA and inclusive preschools), as well as children in the 5-10 year range.

She currently is one of the Directors and the Chief ABA Officer for Remi-Vista, Inc. and directs the Infant Development Program (home visiting services) in Butte, Shasta, Siskiyou and Trinity Counties, as well as the intensive early intervention ABA services for children with ASD, and the school and SELPA behavioral intervention services for children of all disabilities in preschools through high school. She has also worked as an adjunct professor with multiple universities. Besides the United States, she has worked with professionals, universities, non-profit organizations and families with children with ASD and other disabilities in Australia, New Zealand, Ireland, Russia, Nigeria, Chile, Abu Dhabi and Dubai. She is the author of the book *Successful Inclusion Practices for Children with Autism: Creating a Complete, Effective, ASD Inclusion Program (Preschool through 6th grade)*; the book *Discrete Trial Training, 2nd edition*; and is co-author of the book *Autism Spectrum Disorders: Interventions and Treatments for Children and Youth*.
